

# D&S IFCA Fishing Activity Survey

## A Call for Information: Dart Estuary Marine Conservation Zone



### **What's the purpose of this information gathering exercise?**

Devon & Severn Inshore Fisheries & Conservation Authority (D&S IFCA) is undertaking an assessment of fishing activity in the Dart Estuary Marine Conservation Zone (MCZ). For the first stage of this assessment, officers are gathering information and evidence to better understand fishing locations, levels of activity, and what is important to stakeholders in this area. D&S IFCA officers are particularly interested to gather information on the level and locations of bait digging/ hand gathering, seine netting, and potting.

### **Why is this information needed?**

D&S IFCA has limited evidence and data in relation to fishing activities within the Dart Estuary MCZ and would like to better understand fishing activity within the site. This request for information will allow D&S IFCA to estimate how much activity is currently taking place over the different features of the MCZ. This will also help to build an understanding of how important the site is as a fishing ground to those who use it.

### **How will your information help us?**

D&S IFCA will collate the information you provide, and this will feed into the MCZ assessment and fishing activity report of the Dart Estuary MCZ. D&S IFCA has a duty to manage fishing activities within the inshore (0-6nm) area and, as such, must take the necessary steps to ensure that the conservation objectives of MCZs are furthered. The assessment is used to consider whether the fishing activity may hinder the conservation objectives of the MCZ. If a detailed assessment suggests that the activity is likely to hinder the conservation objectives, appropriate management is required to counter such effects. More complete information on current fishing activities may reduce the level of precaution required in management approaches. Management of fishing activities can be introduced through statutory measures in the form of byelaws, or on a voluntary basis via Codes of Conduct.
