### **BASS - MCRS**

- IFCAs used to enforce MCRS set out in EU Regulation 850/98 against RSA.
- EU Reg 850/98 revoked and replaced by EU Reg 1241/2019.
- EU Reg 1241/2019 explicitly removes the application of MCRS on recreational fisheries including RSA.
- D&S IFCA currently enforces relevant MCRS against recreational fishers engaged in netting, potting and diving through its Permit Byelaws.
- D&S IFCA could look to introduce a generic MCRS byelaw or an emergency byelaw.
- D&S IFCA is planning to consider whether to introduce a hook and line permit byelaw which could include RSA but is at least 18 months away from starting that consideration.



## **BASS - MCRS**

- D&S IFCA could introduce an Emergency Byelaw. Officers currently do not believe that conditions of Section 157 of the Marine and Coastal Access Act 2009 (MaCAA) can be satisfied. - Urgent need.
- Bass Bag limit still in place virtue of EU Reg 124/2019. restricts fishers engaged in recreational fisheries to one bass per person per day 1<sup>st</sup> April to 31<sup>st</sup> October. No bass at other times of the year.
- This limits opportunity to take more bass no MCRS does not apply to RSA.
- Enforcement action against recreational fishers is low and generally a good awareness of bag limit among anglers inspected ashore and afloat.



## Skerries Bank Code of Conduct



#### Netting and Longlining

- ⇒ No commercial targeted fishing for plaice by any method may take place within the entire area of the Skerries Angling Zone.
- Vessels which exceed 10m in overall length are prohibited from engaging in any commercial or recreational netting or longlining activity within the entire area of the Skerries Angling Zone.
- All nets used within the pilot Angling Zone should be clearly marked using buoys with flags to aid efficient differentiation between pots and nets.

#### Recreational Angling

- There is a bag limit for recreational sea anglers fishing within the Angling Zone of 10 plaice and 3 rays per angler per day.
- Handle all fish carefully particularly those you intend to return to the sea alive.

#### Monitoring

- ⇒ From 1<sup>st</sup> January 2015 a monitoring programme will be put in place to assess potential benefits of the Angling Zone to the RSA sector
- ⇒ To support the data gathering anglers using the site are encouraged to engage with IFCA officers and spread awareness of the Angling Zone amongst fellow anglers and encourage adoption of the code of conduct.

## **Angling Zones**

3 Angling zones created under D&S IFCA's Angling strategy 2014-2016.

Zones created to see whether development of RSA could be achieved.

Baseline report produced for Skerries Bank Angling Zone available on D&S IFCA website.

Considerable lapse between data gathering (2014) and report (2019).

Future work;

Engage with all three sectors using the site, examples from around the world indicate that co-management approach involving all interested parties most effective.

Engage in further discussions with relevant stakeholders using baseline report evidence.



## Possible development of hand working permit byelaw

Handworking activities broken down into three categories;

Crab tiling, bait digging and hand gathering.

Pre consultation carried out throughout 2019.

D&S IFCA to consider appropriate management of activities in November 2019.

Possible management may include development of a hand gathering permit byelaw.

Proposed management would be consulted on fully.
