<u>A Call for Information: Bait digging and hand gathering in Marine Conservation</u> Zones



What's the purpose of this information gathering exercise?

Devon & Severn Inshore Fisheries & Conservation Authority (D&S IFCA) is undertaking an assessment of bait digging and hand gathering activity in the following estuaries that are designated Marine Conservation Zones (MCZ); Otter, Axe (Lyme Bay), Erme, Devon Avon, and the Dart.

For the first stage of this assessment, officers are gathering information and evidence to better understand locations of bait digging and hand gathering, levels of activity, and what is important to stakeholders in this area. It should be noted that this request for information is only in relation to the estuaries mentioned above and is not connected to the recent call for information circulated in 2019 on bait digging and hand gathering.

Why is this information needed?

D&S IFCA has limited evidence and data in relation to bait digging and hand gathering within these MCZs and would like to better understand the activity within the sites. This request for information will allow D&S IFCA to estimate how much activity is currently taking place over the different features of the MCZs. This will also help to build an understanding of how important the sites are as fishing grounds.

How will your information help us?

D&S IFCA will collate the information you provide, and this will feed into the MCZ assessment and fishing activity report of the five estuaries mentioned above. D&S IFCA has a duty to manage fishing activities within the inshore (0-6nm) area and, as such, must take the necessary steps to ensure that the conservation objectives of MCZs are furthered. The assessment is used to consider whether the fishing activity may hinder the conservation objectives of the MCZ. If a detailed assessment suggests that the activity is likely to hinder the conservation objectives, appropriate management is required to counter such effects. More complete information on current fishing activities may reduce the level of precaution required in management approaches. Management of fishing activities can be introduced through statutory measures in the form of byelaws, or on a voluntary basis via Codes of Conduct.
