


D&S IFCA Set to Close Public Shellfish Beds

Public Shellfish Beds in the Teign And Exe Estuary will be closed on 1st May 2019




The D&S IFCA Byelaw & Permitting Sub-Committee has taken the decision to apply a temporary closure to public shellfish beds in both the Teign and Exe Estuary. Defined areas in both estuaries will closed from 1st May 2019. The closure applies to both commercial and recreational fishers and is for mussel, not other shellfish such as oysters, clams and periwinkles.


Where exactly are the closures?



Exe: The Eastern Banks (Larger Chart)


Charts have been prepared of the specific areas that are closed and look out for D&S IFCA notices of the areas that are being placed in strategic locations in both estuaries.

D&S IFCA are seeking your views on the management of Bait Digging.





Increased patrol capabilities for D&S IFCA

Launch of new patrol vessel, named David Rowe in memory of former Authority Member



On 14th March, D&S IFCA launched and named their new 7.8 metre patrol boat, Fisheries Patrol Vessel (FPV) David Rowe, in memory of the former Authority member who sadly passed away last April.

Members of David's family joined Authority members and D&S IFCA Officers at the naming ceremony in Brixham.

David was the Chairman of the <u>Byelaw</u> and <u>Permitting Sub-Committee</u> and oversaw D&S IFCA's pioneering use of activity based permitting Byelaws. D&S IFCA is the only IFCA to use these to deliver its management. David was a tremendous supporter and advocate for the D&S IFCA who are proud to name the boat in his memory.

D&S IFCA have been conducting joint patrols with the Marine Management Organisation (MMO) in preparation for the EU exit.



Recently D&S IFCA have been supporting the Marine Management Organisation (MMO) with their EU Exit preparations by conducting joint patrols that have extended outside the D&S IFCA boundaries out to the 12 Nautical Mile limit.

The most recent patrol included the boarding and inspection of a foreign fishing vessel which resulted in an offence being detected.

Environment News

Comprehensive Review Planned for the Live Wrasse Fishery

Restrictions on the fishery are un-changed to allow for a third year of consistent monitoring.



The fishery will be monitored for a third year so a comprehensive review relating to three years of consistent data can be conducted. The results will be assembled into a full report that will be presented in February 2020 to the D&S IFCA Byelaw and Permitting Sub-Committee. There are no changes this season to either the relevant Potting Permit Conditions or any of the voluntary measures that include limiting where the activity can take place.

The meeting provided an opportunity for everyone to come together and present on the work they are currently conducting and the current management on the Live Wrasse Fishery and looking ahead to 2019 and beyond.

Legislation & Permits

Bass Restrictions for 2019

In 2019 between the 1st April and 31st October the restrictions for catching bass by recreational fishers is one per person per day.



New regulations have been published. For recreational fishers a bag limit of one European Sea Bass (*Dicentrarchus labrax*) per day from the 1st April to 31st October 2019 will be implemented.

What does this mean?

1st January to 31st March 2019, it is catch and release only for recreational fishers

1st April to 31st October 2019, a bag limit of one fish per day is allowed

1st November to 31st December 2019, it is <u>catch and release only</u> for recreational fishers

The MCRS for Bass remains at 42cm.

Marine Management Organisation

Do you need a permit?

D&S IFCA issue permits to manage different fishing activities. These include:

- Mobile Fishing (Trawling, Scallop Dredging & Ring Netting)
- Potting
- Netting
- Diving for crab, lobster and scallops

If you conduct these fishing methods, you need a permit. Visit our <u>on-line shop</u> or contact the office to get an application form. Have a look at our <u>enforcement page</u> and scroll down to examine the different permits to see what conditions of use apply.
