Fisheries in EMS Habitats Regulations Assessment for Amber Activities

Further to the Defra's Revised Approach on the management of commercial fishing activities within European Marine Sites, the Devon and Severn Inshore Fisheries and Conservation Authority (D&S IFCA) has undertaken Habitats Regulation Assessments (HRA) on the Amber risk fishing activities taking place within Plymouth Sound and Estuaries EMS. D&S IFCA Officers have reviewed the five previously produced HRAs on the interaction of fish traps on features of the Plymouth Sound and Estuaries EMS, in light of all previous data together with data collected and analysed from the 2020 fishery. The revised HRAs accompany this letter for the gear feature interactions shown in the tables below. These assessments demonstrate that there will not be any adverse effect on the sub-feature for which the site is designated.

I would kindly request that Natural England review and provide formal advice on these assessments.
