## Introduction

D&S IFCA (the Authority) has statutory duties as specified within the Marine and Coastal Access Act 2009 (MaCAA). The Act contains several sections relevant to IFCA work; however, Section 153 (Management of Inshore Fisheries) and Section 154 (Protection of Marine Conservation Zones) are of particular significance.

The Authority inherited many byelaws from its predecessor organisation Devon Sea Fisheries. For its byelaw review, and when new management has been required, the Authority has adopted an activity-based approach and the use of permit-based byelaws that introduce flexible and inclusive management.

The introduction of a permit-based model has enabled large numbers of management measures to be retained or introduced to manage different fishing activities, rather than retain or increase the numbers of standalone byelaws. Current permit-based byelaws include:

- **Mobile Fishing Permit Byelaw**
- **Potting Permit Byelaw**
- **Netting Permit Byelaw**
- **Diving Permit Byelaw (for specified shellfish)**

The Authority has delegated powers to the Byelaw and Permitting Sub-Committee to undertake byelaw related working, including the review of any permit conditions introduced under the permit-based byelaws.

### Information for Readers:

This guide is intended to provide key information relating to the development of the Authority's byelaws and permit conditions.

The Authority is transparent with information that has been created and used in the decision-making processes.

All reports created for the Byelaw & Permitting Sub-Committee (B&PSC) and the minutes from B&PSC meetings can be found in [Section B of the D&S IFCA Resource Library](#). ## Emergency Application Byelaw/Exemptions Byelaw 2019

An Emergency Application Byelaw was introduced on 9<sup>th</sup> May 2018. This byelaw enabled dispensations to be issued. The content of the Byelaw was focussed on the following:

- a. Scientific Purposes
- b. Stocking Purposes
- c. Breeding Purposes

A replacement to the Emergency Applications Byelaw was needed. The Byelaw & Permitting Sub Committee (B&PSC) discussed how to proceed and introduce a replacement at their meeting in October 2018. Establishing the scope of the Byelaw formed part of those discussions. Members of the B&PSC agreed to formulate a Byelaw Technical Working Group (BTWG) to conduct drafting work on their behalf and terms of reference were agreed which included a reporting requirement.

## Size of Vessels Byelaw (Remake)

A Size of Vessels Byelaw (18) was inherited from Devon Sea Fisheries Committee (DSFC) and must be formally reviewed by D&S IFCA. The review requires the re-making of the Size of Vessels Byelaw that will remain as a stand-alone byelaw, rather than the restrictions being applied to the activity Permit Based Byelaws developed by the Authority do date. The task of remaking the Size of Vessels Byelaw became a key task in D&S IFCA's Annual Plan 2021-22.
